STRANGULATION HAZARD

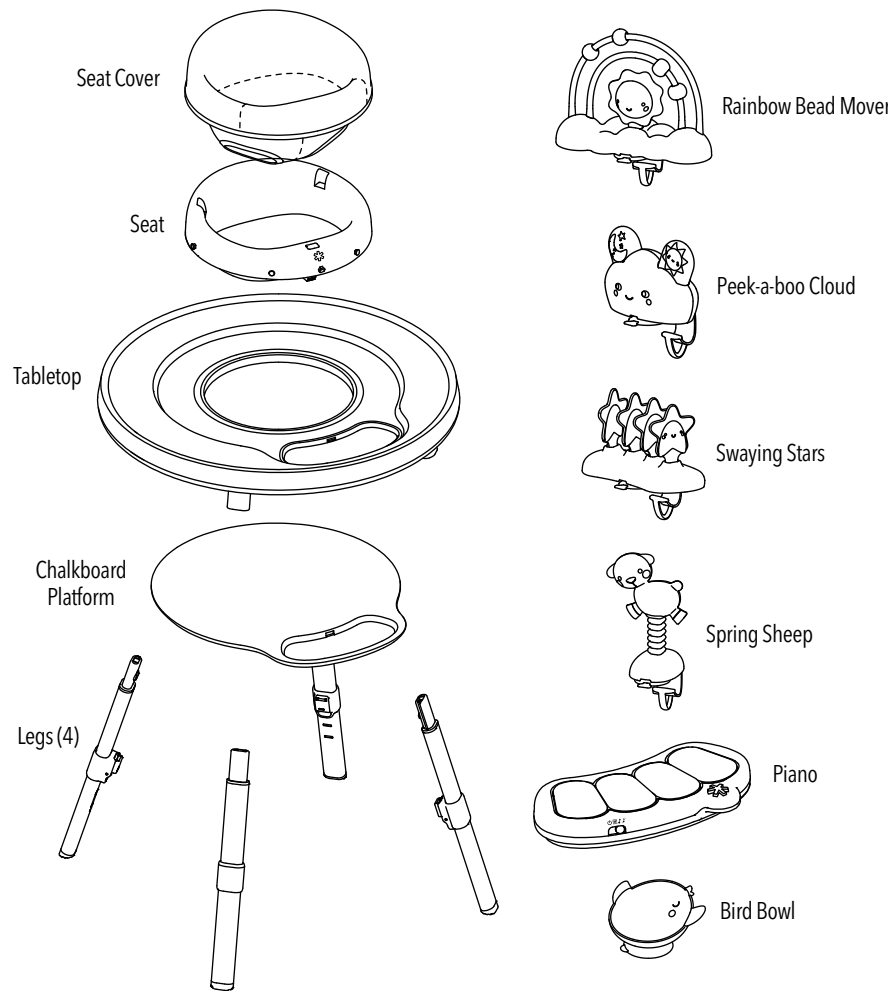
Strings can cause **STRANGULATION**.

CLEANING AND CARE:

Plastic Parts: Wipe surfaces with mild soap and water. Air dry.

Bird Bowl: Wash thoroughly before use. Dishwasher safe, top rack only.

Fabric Parts: Machine wash cold, gentle cycle. No Bleach. Dry Flat. Do not iron. Do not dry clean.

Chalkboard Platform: To remove chalk, wipe clean with a wet cloth.



SETUP AS ACTIVITY CENTER:

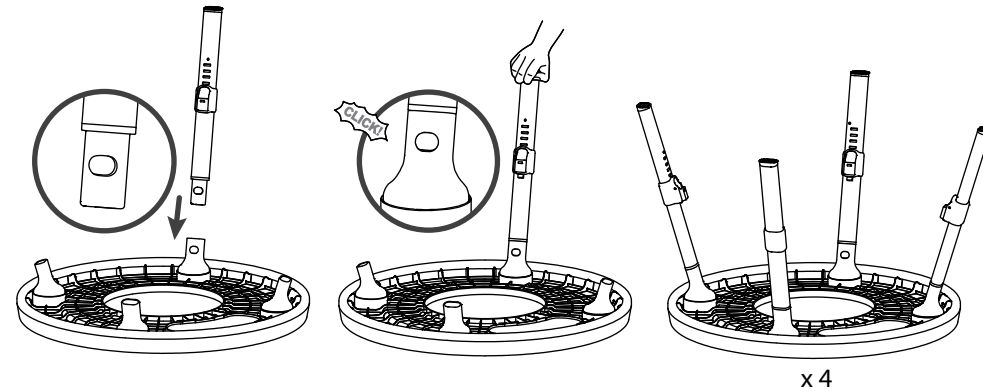
Adult assembly required.

CAUTION: Do not use with children over 25 lbs (11kg), or over 30 inches (76cm) For use only with infant who can hold up their head unaided.

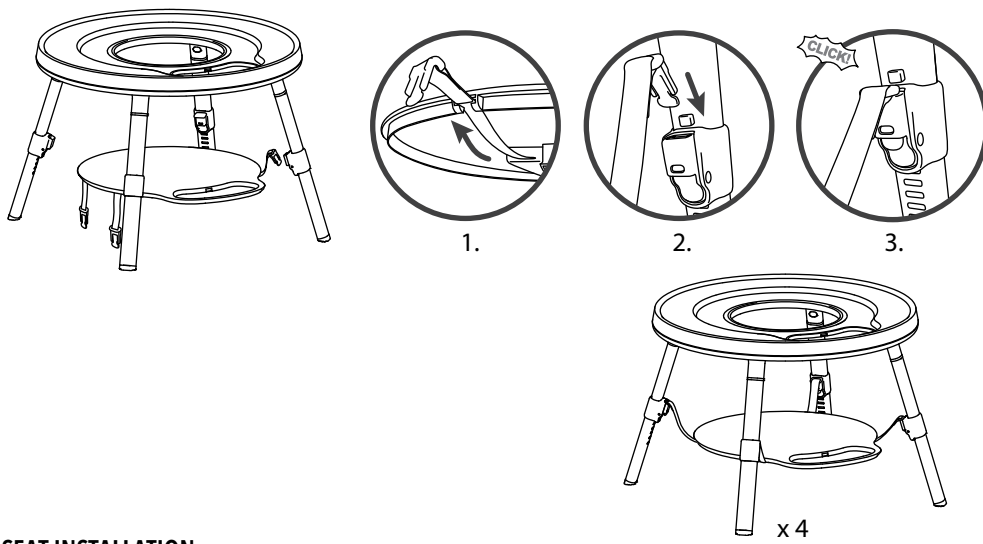
Discontinue use when child begins to walk unassisted or can lift itself out of seat.

LEG ASSEMBLY

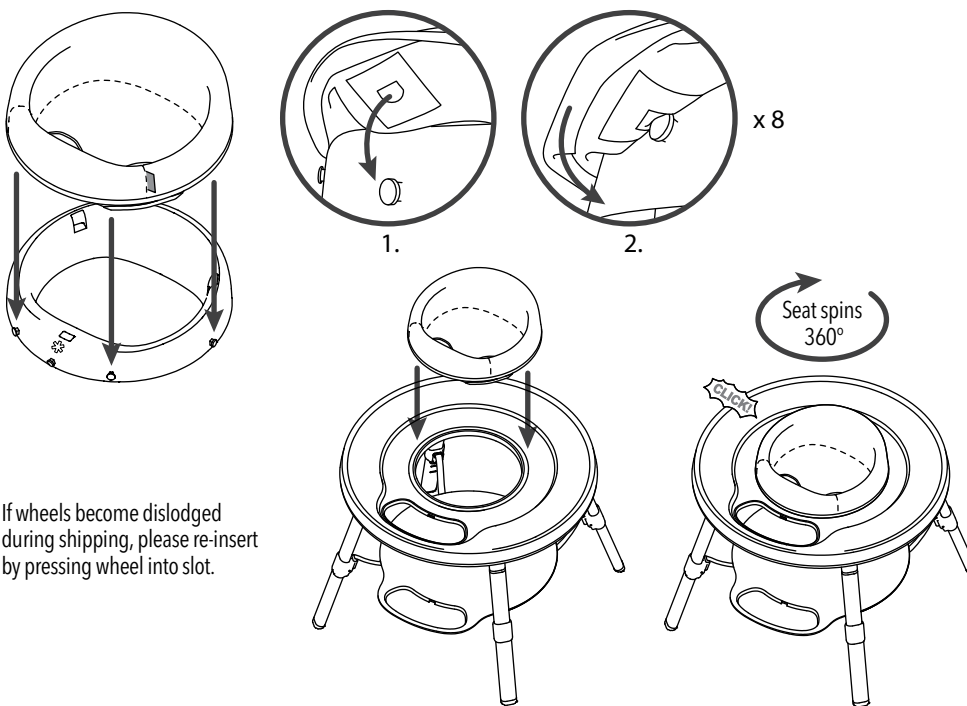
CAUTION: Make sure all 4 legs are securely locked in position before putting your child in the seat.



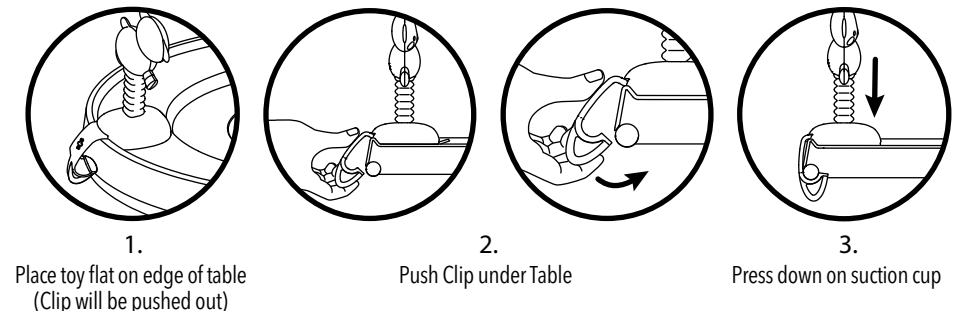
PLATFORM ASSEMBLY



SEAT INSTALLATION



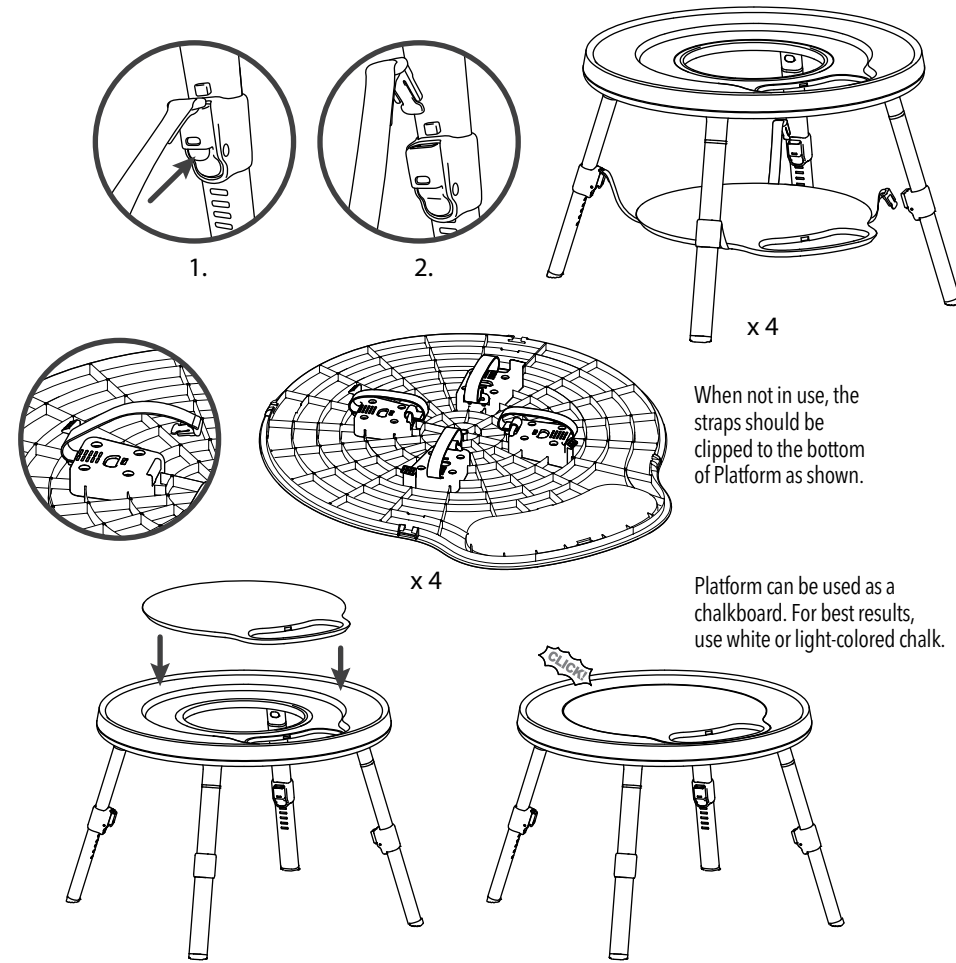
INSTALLING TOYS

Remove Seat and Toys from Table (see "MOVING AND REMOVING TOYS").

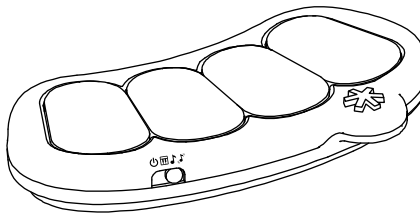


PIANO PLAY: (requires 3 AAA batteries)

Install/replace batteries (by adult only):

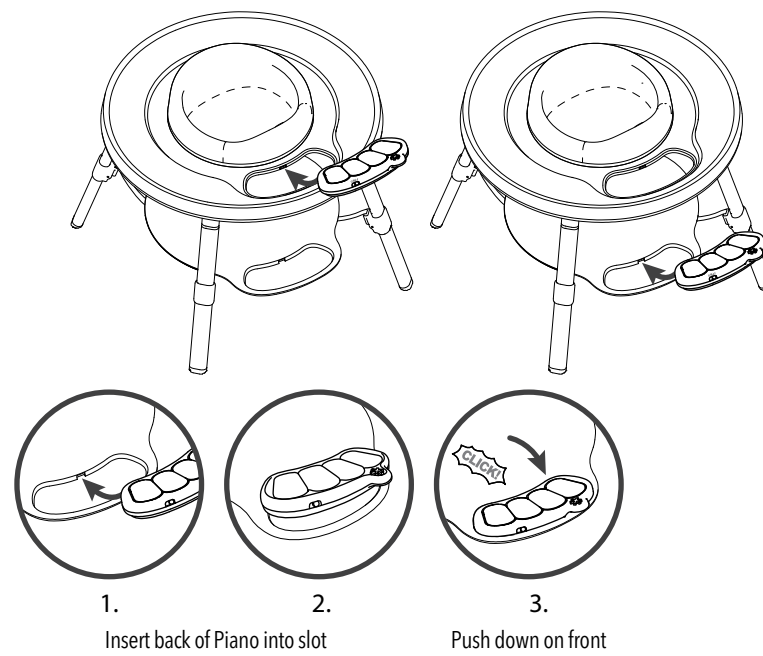
- Open battery cover with screwdriver
- Insert or replace with 3 AAA1.5V batteries
- Replace cover and secure screws with screwdriver

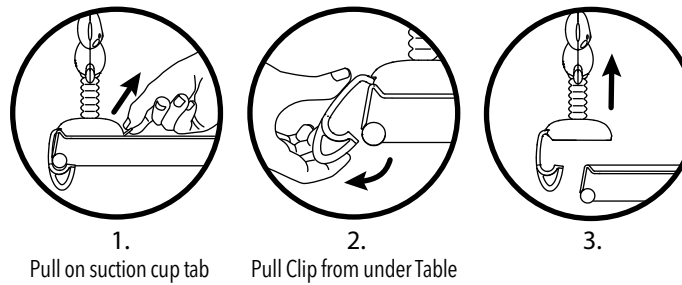


- Create your own music.

INSTALLING PIANO ON TABLE OR PLATFORM

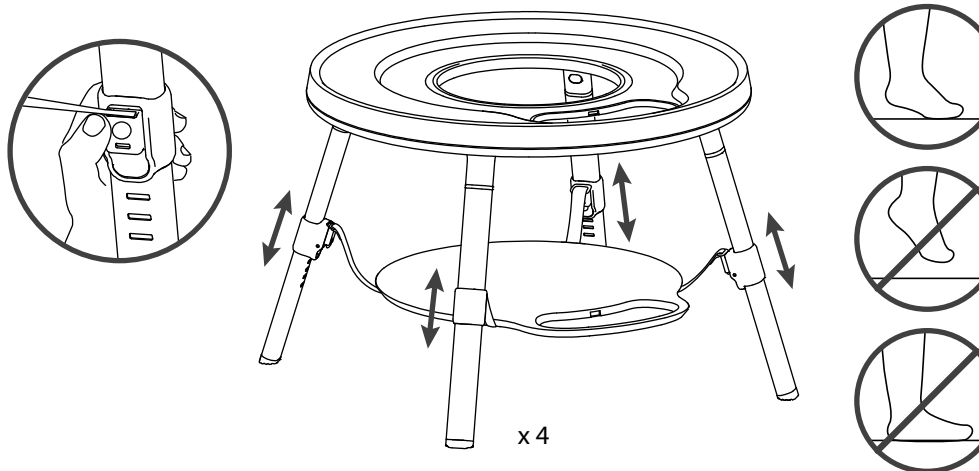


MOVING AND REMOVING TOYS
